² All per MWh pricing is shown rounded to the nearest fourth decimal place. For Eastern RTOs (PJM, ISO-NE, MISO, and NYISO) and ERCOT, the average peak hours per month are 340 and the average off-peak hours per month are 390; the average peak hours per year are 4,080 and the average off-peak hours per year are 4,680. For CAISO and Mid-Columbia, the average peak hours per month are 410.
